

## LEGAL WAIVER 86

In Matthew 10:33

Jesus says:

“But whoever disowns me before others, I will disown before my Father in heaven.”

In Matthew 4:4

Jesus says:

“It is written, ‘One does not live by bread alone, but by every word that comes from the mouth of God.’”

In Mark 16:18

Jesus says:

“...and when they drink any deadly poison, it will not hurt them at all;...”

- 1 I declare that I am a U.S. citizen of voting age and that I am of sound mind and have not been under the care of any mental health care professional in the past three (3) years.
- 2 I acknowledge that my signature on this legal and binding document declares that I am commanded by my inerrant and infallible Holy Bible God in Matthew 4:4 to live by His every word and that I, as a believer and follower of Jesus Christ, according to Mark 16:18: I can drink any deadly poison and that it will not hurt me at all. As a believer and follower of Jesus Christ, for me to willfully give myself any deadly poison I cannot do, as that would be me testing the Holy Bible God, which I cannot do as per Matthew 4:6-7; however, if I am given any deadly poison by another/others that would be them testing – and not me – the truthfulness of my inerrant and infallible Holy Bible God’s word. By signing this legal waiver – LEGAL WAIVER 86 – I am witnessing to the world the truthfulness of the infallible Holy Bible God’s word that I want everyone living by/under.
- 3 I understand that **BY SIGNING** this document that I am standing upon my First Amendment constitutional right to freely exercise my religion as per Matthew 4:4 and Mark 16:18. My signature on this legal waiver – LEGAL WAIVER 86 -- now waives any and all civil claim(s) and any and all criminal claim(s) by me or my estate against any and all individual(s)/organization(s) involved in administering (whether by force or by secret) any deadly poison to me as I take full responsibility for any and all financial expense(s) along with any and all mental/physical damage(s) I should incur (which includes death) in the event that my inerrant and infallible Holy Bible God’s word and word(s) – in Matthew 4:4 and Mark 16:18 – should turn out to be defective.
- 4 I understand that by **NOT SIGNING** this document that I am declaring that the inerrant and infallible Holy Bible God is unreal and is a myth to be believed non-literally like Santa Claus is believed. This isn’t to unequivocally say: there’s no infallible supernatural Creator, only that it’s not the Holy Bible God. **FACT:** Almost every historian and Bible scholar currently living will tell you that the Santa Claus story and the Jesus birth story are not historical, but mythological. **FACT:** Because the infallible Holy Bible God doesn’t know whether It created beasts first or man first – see Genesis 1:25-26 and 2:18-20 – means an infallible Holy Bible God doesn’t exist. Therefore: **I am NOT SIGNING** this legal waiver because I want to live by fact and not by (Holy Bible God) fiction. **I am NOT SIGNING** this legal waiver because the God of Matthew 10:33 who threatens to

disown me if I don't believe in Him is a fiction: a Santa Claus God: a myth: unreal.

- 5 While spiritual Christians – like Barack Obama and Oprah Winfrey – won't be signing this legal waiver, my signature below declares that I am not mentally ill/mentally incompetent for exercising my First Amendment constitutional right to die or seriously get hurt by signing this legal waiver so that I can prove to the world the truthfulness of the infallible Holy Bible God's word that I want everyone believing in and living under. My signature below also declares that I am aware that there are deadly poisoning instructions below my signature that those doing the poisoning are to carefully read and follow to the letter for this **signed** legal waiver to be considered **valid** and **enforceable** in any police jurisdiction in the U.S.A. and in any court of law in the U.S.A.

**VERY IMPORTANT INSTRUCTIONS FOR THOSE DOING THE POISONING:** Make certain that warning label on poison indicates FATAL IF SWALLOWED. You don't want to use Clorox bleach, for instance, because it's not fatal. Mark 16:18 says '***any deadly poison***'.\*\*\*\*\*Consider wearing a long-sleeved shirt and pants, disposable gloves, and protective eyewear and facial mask in the event of deadly poison splashing.\*\*\*\*\*Remember to bring a pen with you along with this legal waiver -- LEGAL WAIVER 86 – and your chosen **deadly** poison.\*\*\*\*\*Go in a group, if you like. Remember: There's usually a natural reflex reaction when a human is given something to drink not by their own hand. A group can better serve, perhaps, a smoother (forced) administering.\*\*\*\*\*Make sure printed name on LEGAL WAIVER is legible and that birthdate means signee is eighteen (18) years old or older and that there's a signature. This **signed** LEGAL WAIVER 86 now legally allows you to help the signatory take their **Holy Bible God's Mark 16:18 Poison Challenge** with them having assumed all liability.\*\*\*\*\*If the deadly poison is being administered secretly, like being slipped into a drink: make certain you've taken ALL necessary precautions so that no one else but the signatory is drinking that deadly poison drink.

**IN THE EVENT OF A MISHAP AND THE INERRANT AND INFALLIBLE HOLY BIBLE GOD'S WORD BEING DEFECTIVE:**

**If the person is still conscious:** Ask the person to sit still and to spit out anything that is remaining in their mouth. Don't give the person anything to drink. Call **1-800-222-1222** which is the telephone # for Poison Help. Know the name of the poison given and in what quantity for the person at Poison Help.\*\*\*\*\*

**If the person is unconscious:** Try to wake the person and encourage the person to spit out anything left in their mouth. Don't give the person anything to drink. Call **1-800-222-1222** which is the telephone # for Poison Help. Know the name of the poison given and in what quantity for the person at Poison Help.\*\*\*\*\*All who participated in the poisoning are required by law to remain at the scene until medical personnel arrive and to cooperate fully with those medical personnel. You have this signed LEGAL WAIVER 86 to explain what happened. \*\*\*\*\*If the police should be called to the scene: Show the police this signed LEGAL WAIVER 86 and let the police take whatever photo(s) they want of the signed LEGAL WAIVER 86 – if you haven't had a photo session yet yourself, now is a good time. Show the police your ID upon request, and give the police your contact information for their report.

**TO THOSE CONSIDERING AN ARREST:** A U.S. citizen does have the constitutionally-protected right to be a motorcycle daredevil and risk their life/well-being or be a religious daredevil and risk their life/well-being – see sections 2, 3, and 5 of this signed LEGAL WAIVER 86. You've seen the signed LEGAL WAIVER 86 and have all necessary contact information; therefore, any arrest is a false arrest and subject to a civil lawsuit.
